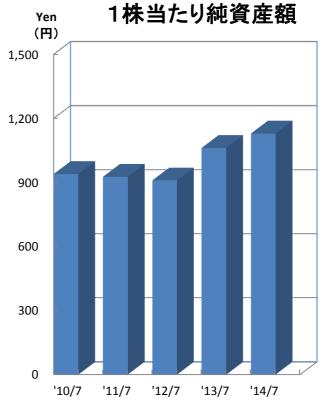


Consolildated Financial Results Per Share (連結1株当たり指標)

Shareholders' Equity per Share

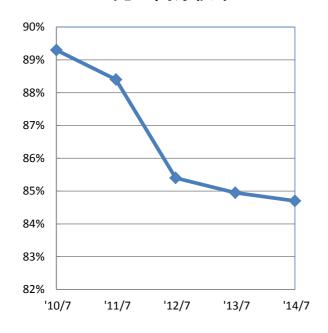

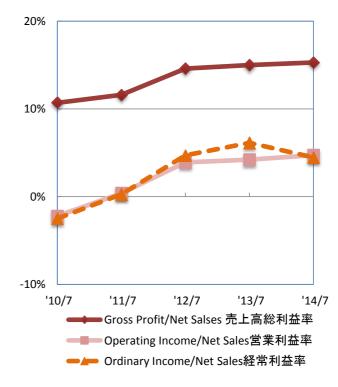

Gross Profit, Operating Income and Ordinary Income against Net Sales 売上高総利益率, 営業利益率, 経常利益率

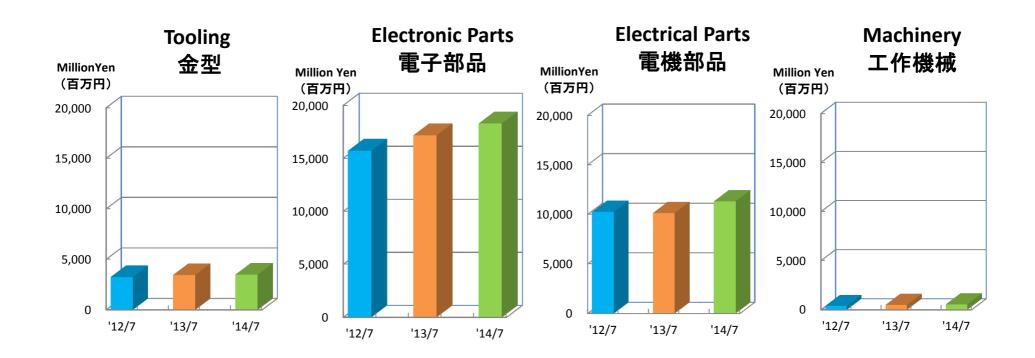

Consolidated Net Sales by Business Segment (セグメント別連結売上高)

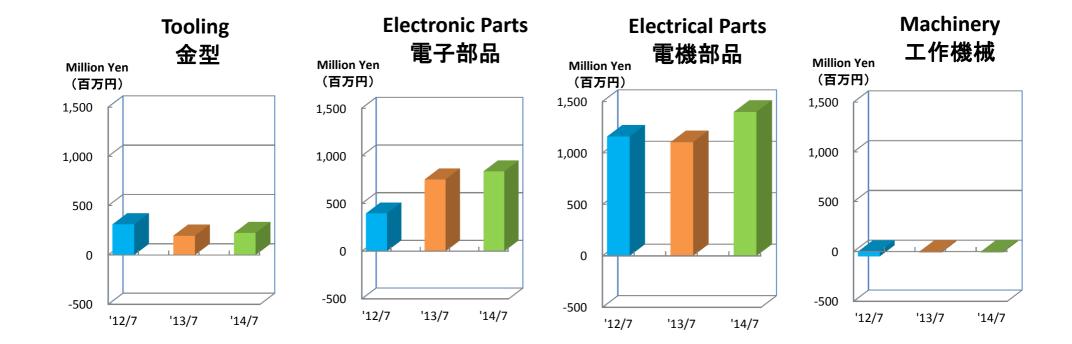
