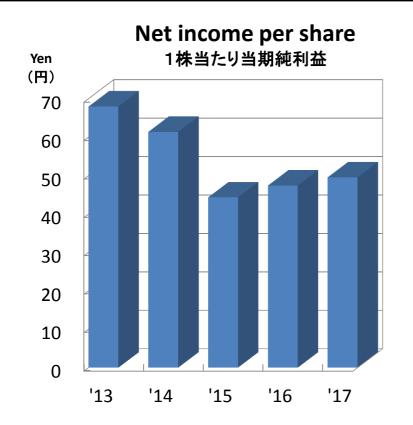

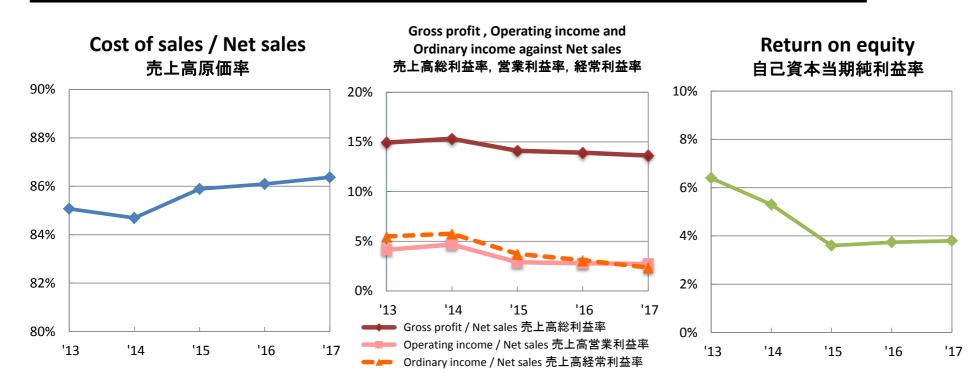

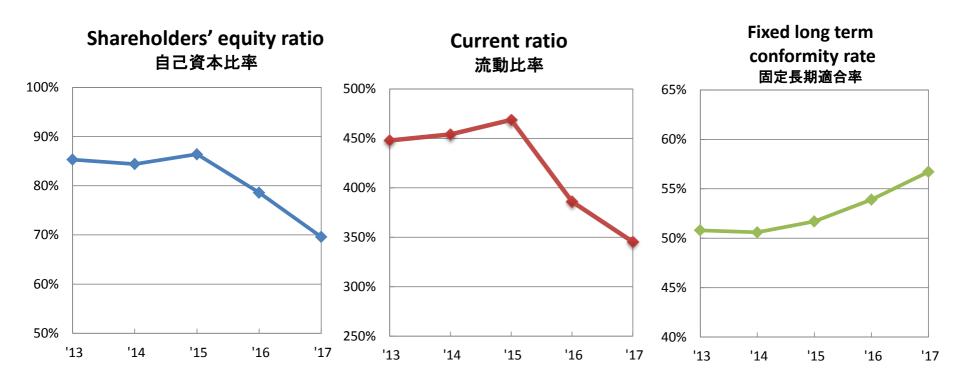

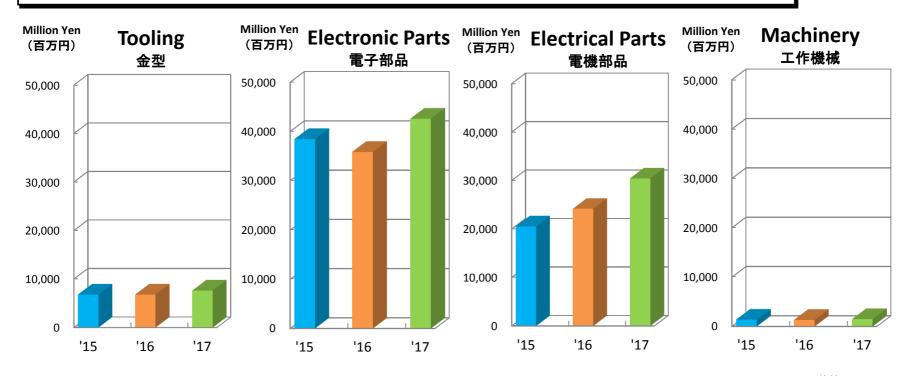

Consolidated Net Sales by Business Segment(セグメント別連結売上高)

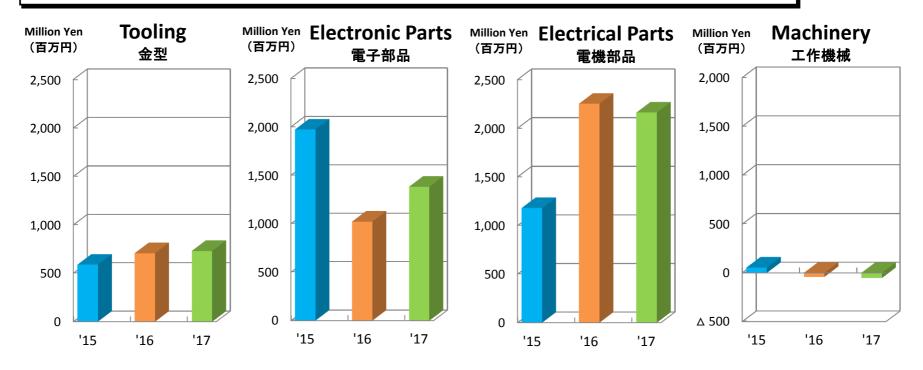
